Employee Notification of VPP Participation & Rights Under OSHA and VPP



The management team at Brieser Construction Company has maintained a long-term commitment to providing our employees with a safe and healthy work environment. Our goal is to provide the employee training, supervision, tools, and management support needed to assure that our employees end each workday safely and arrive home safe and healthy to their families.

Brieser Construction Company has achieved OSHA VPP for Construction recognition. To continuously improve our safety program, we have established specific safety program goals to persevere this approval. We will strive to meet and exceed the four major elements that comprise OSHA VPP.

Major Elements - An effective occupational safety and health program will include the following four elements:

1. **Management Leadership & Employee Involvement:** Management commitment provides the motivating force and the resources for organizing and controlling activities within an organization. In an effective program, management regards workers safety and health as a fundamental value of the organization and applies its commitment to safety and health protection with as much vigor as to other organizational purposes. While the employee involvement provides the means through which workers develop and/or express their own commitment to safety and health protection, for themselves and for their fellow workers.
2. **Worksite Analysis** involves a variety of worksite examinations, to identify not only existing hazards but also conditions and operations in which changes might occur to create hazards. Unawareness of a hazard which stems from failure to examine the worksite is a sure sign that safety and health policies and/or practices are ineffective. Effective management actively analyzes the work and worksite, to anticipate and prevent harmful occurrences.

3. **Hazard Prevention and Controls** are triggered by a determination that a hazard or potential hazard exists. Where feasible, hazards are prevented by effective design of the jobsite or job. Where it is not feasible to eliminate them, they are controlled to prevent unsafe and unhealthful exposure. Elimination or controls is accomplished in a timely manner, once a hazard or potential hazard is recognized.
4. **Safety and Health Training** addresses the safety and health responsibilities of all personnel concerned with the site, whether salaried or hourly. It is often most effective when incorporated into other training about performance requirements and job practices. Its complexity depends on the size and complexity of the worksite, and the nature of the hazards and potential hazards at the site.

OSHA's Voluntary Protection Program (VPP) recognizes workplaces with excellent safety and health management systems and promotes them as model workplaces. A VPP company must have in place an effective safety and health management system that meets rigorous performance-based criteria. In addition, all relevant OSHA standards must be met. OSHA verifies qualifications through a comprehensive onsite review process.

Achieving VPP demonstrates to our employees, industry, customers, and community that Brieser Construction Company is a leader in safety and health. We believe that a voluntary, cooperative, and proactive safety and health partnership of management, employees and OSHA benefits all parties.

An essential component in the VPP process is the demonstrated involvement and support of all employees. Our Safety and Health Committee members will be asked to participate in the VPP process. I am requesting the support of all employees in our mission to continually improve our safety processes and maintain our VPP for construction designation.

If this fails to provide a satisfactory correction, I encourage you to contact me to discuss your concern. If you still believe an unsafe or unhealthy condition exists and it is not being satisfactorily addressed, you have the right to register a complaint with OSHA. The OSHA standard provides you specific protection from retaliatory discipline for exercising this right. You may also review and/or obtain reports of safety and health inspections and accident investigations upon request. The company reserves the right to protect the personal privacy of all employees with regards to accident investigations and may edit portions of reports to assure this privacy protection.

As stated in our *Safety and Health Policy*, we consider safety to be a core value that shapes our behavior. Safety is an essential consideration in all business decisions and is a requirement in the performance of all job tasks. Our goal is to work each day with *Zero Accidents, Occupational Illnesses and Injuries* assuring that **all employees will return home safe and healthy to their families.**
